

**Minutes of Regular Meeting of the  
Alexandria Civil Service Commission  
January 15, 2025, at 2:30 p.m.**

The meeting was called to order by Ms. Connie Baker at 2:50 p.m. The Pledge of Allegiance was recited. Commissioners in attendance were: Ms. Connie Baker, Mr. Donald Collins, Ms. Terri Blaisdell, Mr. Paul Lafleur, and Mr. Charles Harvey. A quorum was present. Staff members present: Ms. Mildred Price, Director of Civil Service; Ms. Toria Banks, Examination Analyst; Ms. Cherrymae Fontenot, Examination Analyst. Also present were Ms. Lisa Harris Director of Personnel, and Mr. Stacy Auzenne, Conflicts Counsel for the Commission, Mr. Joshua Dara Jr., Counsel for the Appointing Authority and Mr. Matthew Nowlin, Counsel for Appellant. The Court reporter was Ms. Treva Maricle.

Ms. Baker read a statement regarding the rights of the public to comment on matters on the agenda prior to action being taken on them, as required by the Louisiana Revised Statutes.

Ms. Baker addressed the agenda item Stacy Hair Appeal Docket No. 2024-01. Ms. Price reminded the Commission that the appeal of Stacy Hair is reset to February 19, 2025.

**Pre-Appeal Motions in the Appeal of Richard Moustier, Civil Service Docket No. 2024-03.** Mr. Dara stated all matters have been resolved in the pre-hearing conference relating to the pre-appeal motions.

**Consideration of a motion to Recess for Executive Session to Consider Pre-Appeal Motions in the appeal of Richard Moustier, Civil Service Docket No. 2024-03.** Ms. Price stated matters were resolved and addressed in the previous agenda item.

**Appeal of Richard Moustier Civil Service Docket No. 2024-03.** The Commission permitted Mr. Dara to present Stipulations of facts on the appeal of Mr. Moustier with no objections. Mr. Nowlin noted disagreement with several facts presented and asked the Commission to disregard items noted from consideration. The Commission agreed to remove from consideration.

After further discussion, Mr. Dara asked the commission to grant the motion for summary disposition. Mr. Nowlin asked the commission to deny the request to grant the motion for summary disposition.

**Consideration of Motion to Recess for Executive Session to Consider the Appeal of Richard Moustier, Civil Service Docket No. 2024-03.** Ms. Baker accepted a motion to recess for executive session to discuss the appeal of Richard Moustier by Mr. Lefleur. Mr. Collins seconded the motion, and upon roll call vote, the motion carried unanimously.

Ms. Baker accepted a motion to exit executive session by Mr. Harvey. Ms. Blaisdell seconded the motion, upon roll call vote the motion carried unanimously.

The Commission voted 5 to 0 granting the City's Motion for Summary Disposition. The Alexandria Civil Service Commission affirms the termination. The Commission voted 5 to 0 denying Mr. Moustier's position of Summary Disposition. Mr. Nowlin stated he objected, for the record.

There was no discussion under **New Business (no action will be taken)** on the agenda item.

The commission adjourned at 4:00 p.m., following a motion by Mr. Collins and seconded by Mr. Harvey.
