Energy Cost Adjustment (applicable to all rate schedules):

All kwh rates for metered sales will be increased or decreased 0.011 cent per kwh for each 0.01 cent per kwh, or major fraction thereof, by which the average cost per kwh for net generation and purchased energy (determined as the sum of the fuel cost of city generation and the energy portion of purchased power for the second preceding calendar month divided by the total kwh delivered to the Alexandria system during the previous calendar month).

Infrastructure Renewal Assessment (applicable to all rate schedules):

From May 1, 2012 until this subsection is amended after a subsequent final, approved and implemented rate reform or April 30, 2015 there is imposed for electrical service to all residential consumers located inside the city limits and to residential customers located outside the city limits a monthly electrical service infrastructure renewal assessment:
